## Advanced Standing Assessment Rules

Students can only apply for Advanced Standing at the beginning of their program. Advanced Standing applications received by current students midway through their program or for courses already attempted will be rejected. Students may receive Advanced Standing for up to a maximum of 50% of their course in CIM program.

- A course for which Advanced Standing is being applied, must be at least 80% similar in content to the course studied at another institution.
- Previous study graded as Advanced Standing cannot be used for Advanced Standing.
- Any study cited in an Advanced Standing application must have been completed within the past seven years.
- Approved study must have been completed at a comparable Australian Qualifications Framework (AQF) level. Examples of approved study Qualifications from accredited Australian Higher Education institutions or equivalent overseas institution as assessed by the National Office of Overseas Skills Recognition (NOOSR).

**Please Note:** While CIM will take every effort to ensure that Advanced Standing for accounting/information systems courses meet the criteria of professional accounting/information systems bodies, it is the discretion of the professional accounting/information systems bodies whether to accept the Advanced Standing granted by CIM. CIM encourages students applying for Advanced Standing for accounting/information systems courses to seek advice from the relevant professional accounting/information systems body prior to applying.
